III. General Company Description

<u>Mission Statement</u>: The purpose of Bryan Whitehead's Piano Studio is to cultivate aspiring pianists into experienced musicians by introducing a variety of genres of different time periods, teaching good practice habits, encouraging creativity, and organize performance opportunities.

<u>Company Goals and Objectives</u>: My goals are to create a musically enriching environment that can sustain itself financially by catering to the pianists' needs accordingly. My objectives are to help the beginning pianists to understand the general topography of the piano; to comprehend Western art music theory; to perform studied works at studio, ensemble, or public recitals and local, regional, or state contests; to enhance overall keyboard music appreciation.
